The breakeven charts indicate levels of income that would prohibit payment of SSI benefits in deeming situations. These charts are <u>informational only</u>. In any given situation, a computation should be done taking into consideration other variables such as: impairment related work expenses; blind work expenses; plans for achieving self-support; and the fact that assistance based on need, and any income used to compute such assistance, is not deemable.
